## Ohio 9-1-1 Ride-Along with Marion Fire



The Public Safety Ride-Along Program of the Ohio 9-1-1 Program Office continued in March as Ohio 9-1-1 Administrator Rob Jackson rode along with the Marion Fire Department.

The Marion crew members gave valuable insight into their operations and the needs they have concerning 9-1-1 and dispatching. Overall, a variety of EMS calls were handled, along with a fire alarm that turned out to be a false alarm. The Marion Fire Department crew were very accommodating and the ride-along was very beneficial.

## **Federal Engineering Comprehensive NG9-1-1 Recommendation**

At the June 29 meeting of the Ohio Statewide Emergency Services Internet Protocol Network (ESINet) Steering Committee, Ohio's NG9-1-1 consultants from Federal Engineering (formerly L.R. Kimball) gave their comprehensive recommendation as to the development of a Next Generation 9-1-1 system in Ohio. Barbara Vos, project manager for Federal Engineering, briefed committee members on the major points of the detailed report, which provided a number of specific recommendations.

First, Federal Engineering recommends the State of Ohio move toward a universal device fee, rather than just a wireless fee. This approach would include landline, VOIP, wireless and other devices capable of contacting 9-1-1. The universal device fee would allow the State of Ohio to continue disbursements to the counties, but also provide for a central call routing and core services system available to the counties.

In addition, Federal Engineering recommends a cohesive 9-1-1 approach. This includes all PSAPs, rather than just PSAPs that initially answer wireless 9-1-1 calls, be required to follow the PSAP Operations Rules and criteria established and ensure that however a citizen contacts 9-1-1, they receive consistent and professional service. ## **Combined PSAP Operations and Technical Standards Subcommittee Meetings**

In anticipation of the recommendations made by the NG9-1-1 consultants from Federal Engineering discussed above, the PSAP Operations Subcommittee and the Technical Standards Subcommittee have held a series of meetings to discuss potential revisions to ORC Chapter 128. These meetings have focused on reviewing the current law to identify language that needs to be modified to allow the most advantageous environment for NG9-1-1 to be developed in Ohio.

Thus far, the meetings have been well attended and the chairs of each subcommittee have received an abundance of valuable input from stakeholders throughout the 9-1-1 community. Areas of focus have included definition changes, expanding the scope of ORC 128 to include all of 9-1-1 rather than just wireless 9-1-1, and altering the funding method currently in use for 9-1-1 at the state level. Key participation from a variety of organizations, such as the Buckeye State Sheriff's Association, Ohio APCO and the Ohio Fire Chief's Association to name just a few, has been a critical component in making this process successful.

## **New ESINet Steering Committee Members**

Three new legislators have joined the ranks of the ESINet Steering Committee in 2017: Sen. Frank Hoagland, Sen. Sean O'Brien and Rep. Rick Carfagna. Each brings valuable experience and presence to

the steering committee that will aid in moving NG9-1-1 forward in Ohio.

Sen. Frank Hoagland joins the committee from Ohio Senate District 30, representing portions of southeastern Ohio. He is serving his first term as a member of the Ohio Senate.
